available.
3. Participation will be limited to your team roster with tournament pick-ups or tryout players excepted.
Maximum roster not to exceed sixteen on an everyday basis.
4. Individual work or small group work on an unscheduled basis will be allowed when the facilities are
available and will be limited to your team roster.
5. Proper care and maintenance of the facilities will be necessary.
6. Good sportsmanship and cooperation with each other will be appreciated.

Liability:

I release Triple Crown Academy and the Triple Creek Complex's owner/officers, instructors, employees,
and any and all sponsors, from liability due to injuries incurred by said athlete during team workouts.
